



## SUMMER 2026 IMPORTANT PAYMENT INFORMATION

### Tuition Payment Deadline – Wednesday, May 13, 2026

Billing of tuition and fees is an automated, electronic process driven by student registration transactions. All student account information and billing statements are available electronically through the Online Student Account Center. CCAC does not mail paper bills. Notifications of eBill statements are issued to the student’s official CCAC academic email. **Students are required to monitor their CCAC email account regularly.**

**Summer 2026 course registration creates financial responsibility for tuition and fees.** Financial clearance of your student account must be achieved by the tuition payment deadline through one or more of the options listed below. **A \$15.00 late payment fee will be assessed to any student account not meeting financial clearance by the published payment deadline.** Additionally, any student account carrying a balance due that is not covered by a payment plan, financial aid or third party sponsorship is subject to a monthly late payment fee.

Registration will be accepted after the payment deadline; payment is due at the time of registration. If you choose not to take class(es), you must **officially** drop your class(es). ONLINE TUITION PAYMENT PLAN	Enroll through the Online Student Account Center. Payment equal to 33 percent of total tuition and fees is due at the time of enrollment in the plan. The balance is payable in two additional equal installments. Future installments may be pre-scheduled using a saved payment method. FINANCIAL AID AWARD	Secure financial aid to cover your balance. Any balance not covered by financial aid is due by the payment deadline to avoid late fees. In order to use financial aid to satisfy charges for Summer 2026, make sure you complete and submit the Free Application for Federal Student Aid (FAFSA) and any other requested documents to a campus Financial Aid office in a timely manner. THIRD PARTY SPONSORSHIP	Secure a third party sponsorship and submit completed form by the payment deadline. Any balance not covered by sponsorship is due by the tuition payment deadline to avoid late fees. Proof of eligibility is required for CareerLink, OVR or Job Corps before the payment deadline. Contact your sponsor to get an authorization letter or clearance form. MILITARY AND VETERAN FUNDING	Veterans, service members and family using GI Bill, MyCAA or Military Tuition Assistance must contact Military and Veterans Services. If not covered 100 percent by this funding, any balance due must be paid (or payment plan enrollment completed) by the payment deadline to avoid late fees.
